1. - 1.1 Scope of Work:- To associate EPI for vetting of design and drawing and implementation strategies submitted by EPC contractor for construction/ repairs of the proposed structures, regular site visit, coordination with AAI Engineers & EPC Contractor for design of comprehensive surface drainage system to ensure uninterrupted drainage of storm water, design& technology/construction methodology adopted by EPC contractor for widening of basic strip on western side, any design/construction methodology/ latest techniques proposed by the EPC contractor for retaining hill slope.

A.

1. The measures suggested by the EPC Contractor for restoration/ improvement of existing drains & culverts.
2. The measures suggested by the EPC Contractor for training of Jhoras (natural streams) on the uphill side.

3. *The requisite design & technology/ construction methodology adopted by the EPC Contractor for widening of basic strip on western side.*
4. *The measures specified by the EPC Contractor to strengthen the existing works.*
5. *The construction methodology/design/technique of retaining wall/ structure that includes but is not limited to, the procedure already adopted at site.*
6. *Any other sound design/construction methodology/ latest techniques proposed by the EPC Contractor for retaining the hill slope.*
7. *Any other related activity for smooth progress of works.*
8. *The site shall be visited as and when required for successful completion of above scope of work.*

1. *The geological maps & sections, geotechnical studies relating to the design& concept for construction/ repairs of the proposed structures.*
 2. *The detailed hydrological & drainage study of Pakyong Airport and uphill areas on the western side.*
 3. *The design of a comprehensive surface drainage system, to ensure uninterrupted drainage of storm water (surface and subsurface).*
- 1.2 *The selected agency has to undergo execution of formal pre-bid tie-up MOU with EPI.*

2. ELIGIBILITY CRITERIA

Minimum qualification criteria for Engineering Consultancy firm is as following:

1. *Average Turn Over from consultancy works only for last two financial years should be Rs. 2.0 Crs.*
2. *Organization should be establishment of minimum two years.*
3. *Organization should be having at least one geotechnical professionals Masters in Geotechnical on its permanent role with minimum experience of 15 years with proven track record in geotechnical and slope protection works.*
4. *Bidder should have positive net-worth at the time of submission of BID.*
5. *Consultant should have experience for detailed design and drawings review of analysis & design for stability checking for structures like earthen dam/Stability of heavy structures/ review of gravity dam/stability check for runways/slopes.*

- 2.1 ***Bidder has to submit offer online for above scope of work in the prescribed given BOQ format in compliance to this EOI.***
- 2.2 ***The price offers of only technically qualified bidders will be opened and it will be as per EPIL procedures.***
- 2.3 ***In the subject BID where the parties shall qualify to bid and enter into a Pre-bidding MOU, Parties shall not participate individually directly or indirectly and /or through any joint***

venture / consortium etc. entered into with any other company / organization / proprietor / individual constituted for that particular work.

2.7 **Validity of Tender**

90 (90) days from the date of opening of price bid which shall be further extended by the bidder on request on same terms and conditions.

2.8 *Accessing/Purchasing of BID Documents:-*

Bidder has to refer all tender documents as mentioned in BID. The detailed BID notice is available for download on the websites of EPI: www.engineeringprojects.com & CPP portal: www.etenders.gov.in. Interested bidders are requested to regularly visit the above websites for corrigendum, addendum, extension, or cancellation of this BID, if any. No separate communication shall be sent in this regard.

2.9 **AWARDING OF JOB TO THE ENGINEERING CONSULTANT** *in case the job is awarded to EPI by the Client, EPI will in turn offer the job as per their offer and further negotiation, as necessary. The pre-bid MOU signed with the successful bidder shall be converted in to Work Order.*

2.10 *In case any interested consultant wishes to furnish additional information, which they may consider relevant for assessment of their eligibility and for submission of offer.*

3. *Evaluation Of Technical Bids And Opening & Evaluation Of Financial Bids:*

3.1 **Evaluation of Technical Bids**

3.1.1. *Technical BID of only those Bidders shall be considered for evaluation whose BID have been received within the timeline.*

3.1.2. *Technical Bids of those Bidders, who have not submitted their Bid online, shall not be considered for opening and evaluation.*

3.1.3. *If any information furnished by the Bidder is found to be incomplete, or contained in formats other than those specified herein, the EPI may, in its sole discretion, exclude the relevant information for consideration of eligibility and qualification of the Bidder.*

3.1.4. *To facilitate evaluation of Technical BIDs, the EPI may, at its sole discretion, seek clarifications in writing from any Bidder regarding its Technical BID. Such clarification(s) shall be provided within the time specified by for this purpose. Any request for clarification(s) and all clarification (s) in response thereto shall be in writing.*

3.2. Opening and Evaluation of Financial Offers

Bidder has to submit their offers as financial bid, as given in BID's prescribed BOQ format. The Authority shall inform the venue and time of online opening of the Financial Bids to the technically responsive Bidders through e-procurement portal.

3.2.1 The bidder who will emerge as lowest bidder will be associated as per conditions of this EOI and AAI enquiry.

- 4. The bidder must have no criminal/ economic fraud case is pending or contemplated against the organization. Undertaking regarding the same on the organization's Letter Head should be submitted.*
- 5. Terms and conditions:-*
 - (i) The BID is issued with no commitment from EPI. This association of Agency will be decided on receipt of applications and evaluation of the documents. EPIL reserves rights to withdraw this BID at any time and/or vary and part thereof at any stage. EPIL further reserves the right to disqualify any application, should it be so necessary at any stage.*
 - (ii) The applicants after submitting the response to this BID, agrees with EPIL for honoring all aspects of fair -trade practices.*
 - (iii) Applicant selected shall be notified automatically through their registered emails and or through phone.*
 - (iv) EPIL will enter into Pre-Bid Agreement with selected Associate on the basis of mutually agreed terms and conditions.*
 - (v) Unless otherwise specified anywhere in the document, all technical specifications for work execution shall be as per client's tender condition, latest client specifications and Good Industry Practice.*
 - (vi) Particular conditions of Contract: The interested contractors may refer enquiry document for compliance of Conditions of contract in case considered for association with EPIL as associate for above said tender.*
 - (vii) All other terms and conditions are as per terms and conditions of client for MOU for bidding process.*
 - (viii) Joint Venture is not permitted for BID.*
 - (ix) BID proposal must be submitted together with a covering letter and in English Language only. Bidder has to quote their offer of respective packages online in Envelope-II per BOQ format of BID.*
 - (x) BID document shall be digitally signed by authorized signatory of the Bidder/Applicant and submitted "Online" only. The authorized signatory of Applicant /Bidder must be in possession of Power of Attorney before submitting the digitally signed BID. - (xi) EPI shall consider to award the work under its scope of the work awarded by client to the Associate after retaining a fixed margin of EPIL which will be fixed at the time of signing of MOU.
6. The bidder must not have been blacklisted/ debarred by any Foreign / Indian Government /Semi-Govt./ PSU Organization or any government organization in India. Undertaking regarding the same on the organization's Letter Head should be submitted by authorized persons.
 7. The bidder shall not be under liquidation, court receivership or similar proceedings. Undertaking regarding the same on the organization's Letter Head should be submitted.
 8. The bidders meeting technical and financial criteria shall upload the proposal complete in all respects online. All required documents are to be enclosed failing which EPI may consider the proposal as incomplete and reserve the right to reject the same without assigning any reason.
 9. The selected bidder shall be required to sign the MoU with EPI along with documents as per project/ tender requirements.
 10. **The Associate shall submit full amount of performance bank guarantee and/or any other bank guarantee and obtain insurances etc. as per Client's requirement conditions to EPI wherever required for which BID is applied by the bidder and no interest shall be beared by EPI for the same.**
 11. EPI reserves the right to accept or reject any or all BIDs or annul this process without assigning any reason and re-invite BID at its sole discretion, if required.
 12. The bidder fulfilling the above requirements and willing to associate with EPI, as per the terms given above may address their formal expression of interest on online submission with all prescribed supporting documents / undertakings/Tender Fee mentioned in BID not later than -- 01.07.2024 up to 1100 HRS (IST).
