The bid shall be valid for 90 days from last date of submission of bid. The online bid proposals should be in two parts:

- (ii) The Financial Bid which should be as per the format given. The amount must be expressed in terms of percentage of the project cost.

2. Scope of Work

The detailed of scope is briefly given below but not limited to:

- 2.1) Preparation of General Layout Plan for the entire FGD area for all building/ structure/ facilities/ other infrastructure works.
- 2.2) Civil and Structural drawings, Equipment foundations, Ducting Layout with support structure, Mechanical layout including (not limited but may include others) to Booster fans, Flue Gas ducting, Recirculation Pumps Limestone/Gypsum handling system etc. Fire Fighting and HVAC system, Lighting Protection system, fire detection system, including smoke detectors and fire alarms, power supply, internal and external electrification.
- 2.3) Pre and Post construction approval from Gujarat State Electricity Company Limited (GSECL), local authorities and statuary bodies.
- 2.4) Preparation of NIT/ bid documents including technical specifications, detailed bill of quantity (BOQ) for package contracts, assisting in tendering process, Pre-bid clarifications/meetings, opening & evaluation of tender, justification, preparation of measurement modules for payment to package contractors at different stages of execution.
- 2.5) Modules for Quality Assurance (QA) and Quality Control (QC) measures have also to be prepared by the Consultant for supervision of the work by EPIL.
- 2.6) Coordination with EPIL, Technology Partner & associate Contractor, deployment of expert personnel for clarifications at any stage as and when required, preparations of progress monitoring module to ensure works to be executed as per engineering design, technical specifications and other provisions of contract document within stipulated timeline. Assisting in quantity evaluation, variations etc.
- 2.7) All formalities and clearances with necessary set of designs & drawings for handling over of the project, SOP for running and maintenance of different facilities and equipments, preparation of AMC documents, detailed measurements of Civil, Mechanical, Electrical, Instrumentation to be submit to client after completion of project.
- 2.8) Issue of Eight sets or as per Client (GSECL) requirement of "Good for Construction" working / detailed drawings for execution of works.
- 2.9) Revision of the drawings, if required due to site conditions or changes in site location requiring re-preparation/revision of proposal/drawings, etc.
- 2.10) Consultant shall develop various plans for submission to other authorities for obtaining their approvals. In this connection, Consultant shall obtain plans already available with Gujarat State

Electricity Company Limited (GSECL), Ukai, Gujarat etc., for further development of plans, if required.

- 2.11) Visit the site of work as per the requirement and clarify, offer interpretation of the drawings / specifications, attend conferences and meetings to ensure that the project proceeds generally in accordance to design and render advice on actions to assist EPI.
- 2.12) Inspection and evaluation of construction works with reference to design and drawings will be done as per the requirement till completion of project and certification of the same.
- 2.13) Consultant have to obtain necessary statutory approval as per clause 17.0 of GSECL tender document (pg. 363-364 of 997).
- 2.14) Prepare and submit completion reports and drawings for the project as required and obtain "NOC/Completion/Occupancy Certificate" from statutory authorities,
- 2.15) No extra payment will be paid if any alteration is required by EPI/CLIENT in design & drawing at any point of time.
- 2.16) Consultant shall be responsible for Preparation of Extra / deviated / substituted items analysis with justification, during execution of said work from time to time if any.
- 2.17) Professional liability insurance (PLI) of the project for their scope of work as per NIT, is in the scope of consultant and charges of the same shall be included in the fee quoted by the consultant.
- 2.18) Cost of project may vary but consultancy fee will be payable to the Consultant on their actual quoted Price only.
- 2.19) The approved Conceptual Plan & detailed design, drawings will be copyright of EPI/CLIENT and it cannot be represented anywhere in future by Architect / Consultant.

3. Minimum Eligibility Criteria

The technically and financially sound Consultancy firms who fulfill the following requirements are eligible to participate in this tender:

a)

i. Bidder should have successfully completed following "similar works" during the last 7 (Seven) years by the end of the month prior to the date of NIT:

One similar completed work costing not less than the amount equal to 80% of estimated cost of consultancy work (i.e. ₹ 1.55 Cr).

OR

Two similar completed works for each costing not less than the amount equal to 50% of estimated cost of consultancy work (i.e. ₹ 0.97 Cr).

OR

Three similar completed works for each costing not less than the amount equal to 40% of estimated cost of consultancy work (i.e. ₹ 0.78 Cr)..

ii. The definition of "Similar work" shall mean, The bidder must have successfully completed the consultancy services provided, including detail design and engineering in the area of Power/ Steel/ Oil & Gas/ Petro-chemical/ Fertilizer/ wet Flue Gas Desulphurization..

The intending bidder must submit documentary evidence in support of above in the form of:-

- (i) Copy of work order
- (ii) Satisfactory Work Completion certificate indicating executed value and period of work.
- (iii)Private Party work must be supported by corresponding work order & TDS (Tax Deducted at Source) certificates.

Experience for those works only shall be considered for evaluation purposes, which match eligibility requirement stipulated above, on or before the last day of month previous to one in which tender has been invited (Publication date of NIT). The experience of incomplete/ongoing works as on the last date of eligibility period will not be considered for evaluation. If the referred work includes construction as well as maintenance after construction, the experience of such work may be considered as 'acceptable' if the construction part is completed as on the last date of 'eligibility period', even if maintenance work is ongoing, and the certificate issued clearly stipulates the same.

Completion of works means completion of entire facilities i.e. Design, Engineering, Supply, Installation, Construction and Commissioning of the project.

In all the above cases, while considering the value of completed works, the full value of completed work be considered whether or not the date of commencement is within the said seven years period.

- iii. JV/ Consortium are not allowed.
- iv. For evaluation purpose, the completion cost of works mentioned in the completion certificate shall be enhanced by 7% per annum till the end of month prior to date of NIT.
- v. The experience certificate should be issued by office not below the rank of Executive Engineer /Project Manager / Unit Head.
- vi. The experience certificates issued by Government Organizations / Semi Government Organizations / State Government Public Works Department / Central Government / Public Sector Undertakings / Autonomous Bodies / Municipal Bodies / Public Limited Companies listed on BSE / NSE and private party shall be accepted for assessing the eligibility of the bidder. However, the certificates issued by Public Limited Company & Private Party must be supported by corresponding work order & TDS (Tax Deducted at Source) certificates issued by Income Tax Department.
- b) Additional Eligibility Criteria: The bidder should have either successfully completed consultancy services for wet FGD systems in Thermal Power Plants (TPPs) with a minimum capacity of 200 MW or have work in hand of consultancy services for the wet FGD System with a minimum capacity of 200 MW. Bidder to submit work order/ LOI copy of the same and the completion certificate in case of work is completed.
- c) Should have Average Annual Financial Turnover on Consultancy Services at least Rs. 0.97 Cr in the last three years ending 31.03.2023. Turnover certificate duly certified by a Chartered Accountant with Unique Document Identification Number (UDIN) is to be submitted.
- d) Should have a Banker's Certificate from a Nationalized/ Schedule Bank of the amount equal to 40% of the Estimated Cost put to tender (ECPT). The Banker's Certificate should not have been issued earlier than Three (03) Months of last date of submission of tender.

OR

Net Worth Certificate of minimum 10% of the estimated cost put to tender issued by certified CA with UDIN. The Net Worth certificate shall be of the last financial year ending on 31st March'2023.

The Banker's Certificate or Net Worth Certificate shall be in the format prescribed in Annexure-K.

- e) Should not have incurred any loss in more than two years during the immediate last five financial years ending 31.03.2023. Copies of Annual report/ balance sheet and a no loss certificate duly certified by CA with UDIN shall be submitted.
- f) The bidder firm must not be blacklisted or debarred by any Organization at the time of submission of bid and no work awarded to Firms should have been terminated during last 03 years on the ground of unsatisfactory performance. The firms are required to submit undertaking on their company's letter head in this regard.
- g) The bidder firm must have no criminal/ economic fraud case is pending or contemplated against the organization in any country. The firms are required to submit undertaking on their company's letter head in this regard.
- h) Should have valid Permanent Account Number of Income Tax (Copy of PAN to be enclosed).
- i) Should have valid GST Registration number (Copy of GST Registration certificate to be enclosed).
- j) The Consultant firm required to furnish details of Skilled and Trained Manpower including Engineers, Architects and Technical Staff employed and details of various Software and Hardware available with consultant.

4. Disqualification of the Bidder:

Even though a bidder may satisfy the above requirements, he would be liable to disqualification & not considered for the opening of Price bid if:

- a) Misrepresentation in the forms, statements and attachments submitted in the pre-qualification document are proved to be incorrect, false and misleading.
- b) Record of poor performance during the past 07 years such as abandoning the work, rescinding of contract for which the reasons are attributable to consultant/ bidder or financial failures due to bankruptcy etc. in their ongoing/past projects.
- c) If bidder has submitted incompletely filled in formats without attaching certified supporting documents and credentials to establish their eligibility to participate in the Tender.
- d) If the bidder attempt to influence any member of the tender scrutiny committee. EPI reserves its right to take appropriate action including disqualification of bidder(s) as may be deemed fit and proper by EPI at any time without giving any notice to the contractor in this regard. The decision of EPI in the matter of disqualification shall be final and binding on the bidders.
- e) Not submitted Tender Fee and/or EMD as per NIT condition.
- f) Selection of the consultants shall be subject to thorough verification of their credential through a Committee of experts on PQ Criteria Basis.
- g) In case, any document, information and/or certificate submitted by Tenderer is found to be incorrect/false/fabricated or the Tenderer has breached the terms and conditions of Integrity Pact, EPI at its discretion may disqualify /reject / terminate the Tenderer, forfeit the EMD and the Tenderer shall also be liable to be suspended/ debarred for a period which shall be not less than one year extending till maximum for a period of three years.

- h) In case of bidder currently working with EPI and progress is found unsatisfactory in any of the project, their bid will be rejected.
- i) The Consultant firm require furnishing details of Skilled and Trained Manpower including Engineer and Technical Staff employed and details of various Software and Hardware available with consultant.
- j) Site visit for the subject tender is desirable. The bidders may visit the site to Study/assess the tendered work and also acquaint themselves of the prevailing local conditions before submitting their bid. Bidder has to enclose a self-undertaking for the same.

- **6.** In order to participate, the bidder should have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities.
- 7. Any agencies willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System; through logging on to https://etenders.gov.in/eprocure/app the agency has to click on the link for e- Tendering site as given on the web portal.
- **8.** Instructions / Guidelines for tenders for electronic submission of the tenders have been annexed for assigning the agencies to participate in e-Tendering.
- 9. - 19. Public Procurement (Preference to Make in India) policy is applicable in this tender:

Definitions:

- a) 'Local content' means the amount of value added in India in the total value of the item procured) excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.
- b) 'Class-I local supplier' means supplier or services provider, whose goods, services or works offered for procurement, meets the minimum local content i.e. 50% of total value of the goods, services or works.
- c) 'Class-II local supplier' means supplier or services provider, whose goods, services or works offered for procurement, meets the minimum local content i.e. 20% of total value of the goods, services or works.

d) 'Non – Local supplier' means a supplier or service provider, whose goods, services or works offered for procurement, has local content less than that prescribed for 'Class-II local supplier' as mentioned above.

20. Purchase preference will be given to Class-I local supplier as the case may be as detailed below:

- a) Among all qualified bids the lowest bid will be termed as L1. If L1 is 'Class-I Local supplier' the contract for full quantity will be awarded to L1.
- b) If L1 is not 'Class-I Local supplier', the lowest bidder among the 'Class-I Local supplier', will be invited to match the L1 price subject to 'Class-I Local supplier's quoted price falling within the margin of purchase preference (L1+20%) and the contract shall be awarded to such 'Class-I Local supplier' subject to matching the L1 price.
- c) In case such lowest eligible 'Class-I Local supplier' fails to match the L1 price, the 'Class-I Local supplier' with the next higher bid within the margin of purchase(L1+20%) preference shall be invited to match the L1 price and so on and contract shall be awarded accordingly. In case none of the 'Class-I Local supplier' within the margin of purchase preference (L1+20%) matches the L1 price, the contract may be awarded to the L1 bidder.
- **21.** Class-II Local supplier' will not get purchase preference in any procurement, undertaken by procuring entities.
- 22. The Class- I local supplier/Class-II local supplier at the time of tender shall provide self-certification on their Company letter head as per Annexure- L.
- 23. False declarations will be breach of the code of integrity under Rule 175 (1)(i)(h) of the General Finance Rules for which a bidder or its successors can be debarred for up to two years as per rule 151(iii) of the General Financial Rules along with such other actions as may be permissible under law.
- **24.** A supplier/vendor who has been debarred by any procuring entity for violation of Public Procurement order shall not be eligible for preference under this order for procurement by any other procuring entity for the duration of the debarment.
- **25.** All the bidders (i.e. Class I local supplier, Class II local supplier, Non local supplier) shall provide the percentage of local content in their bid irrespective of whether they are availing or not availing Purchase preference under Public Procurement (Preference to Make in India) policy.
